**Business Gateway**

Business Gateway provides one to one advice to both existing and start-up businesses, workshops on themes relevant to business management such as: a 2 day course on business start-up, marketing, accounting, e-commerce etc. Businesses can also benefit from specialist advisors, and access market research. The [website](#) also offers a wide variety of valuable business information. All services are free.

In its first year, Business Gateway Moray provided advice to 973 businesses, new and existing and assisted 83 businesses to set-up. In the second year, 2010/11, it provided advice to over 1,000 new and existing businesses and assisted 118 businesses to set-up.

**Moray College Life Sciences**

The Group heard that the technical design stage of the Moray College Life Sciences Centre is now progressing and expected to be complete late 2011/2012. It is anticipated that the doors to the facility will be open in time for the start of the session 2013/14.
