REVIEW OF COMMUNITY PLANNING BOARD 31 MARCH 2011

Moray Youth Council

A 'Community Planning Dialogue Evening' took place on Monday 18 April 2011 in the Beechtree Restaurant at Moray College. This get-together provided the opportunity for members of the community planning partners, youth council and the voluntary sector to find out about each other's roles. The emphasis was on informality and brief presentations were given by each partner to help explain what Community Planning is about.

New Economic Strategy for Moray and Elgin

A new Economic Strategy for Moray is being progressed. Community based workshops will be taking place in Speyside, Lossiemouth, Forres, Elgin, Buckie and Keith with further presentations taking place on 12th May and the 9th June and outcomes from them will be used by partners for action planning and priorities. The <u>report</u> details the background of the two projects that are nearing completion and the co-ordinated and proactive way forward for the new strategy.

Moray Community Engagement Strategy

The work of the Short Life Working Group was praised for their level of commitment in producing a Community Engagement Strategy for Moray. A Community Engagement Group will be retained to promote and monitor the strategy and will report direct to the Community Planning Board. The group will retain limited membership and will further report on the action plan which underpins the strategy.
